

# McCurdy Schools of Northern New Mexico CAMP STARS

CONTRACT for SUMMER 2019  
(Please Read Carefully Before Signing)

**THIS CONTRACT** made and entered into by and between McCurdy Schools of Northern New Mexico and \_\_\_\_\_, the Parent(s)/Guardian(s) of the named child, properly signed in duplicate, acknowledges the agreement of McCurdy Schools of Northern New Mexico to accept the named child, \_\_\_\_\_ as a Student for CAMP STARS, summer of 2019. By enrolling at McCurdy Schools of Northern New Mexico CAMP STARS the child, together with his/her Parent(s)/Guardian(s) indicate their willingness to accept and observe the camp's academic, disciplinary and financial regulations.

**Note: McCurdy CAMP STARS does not discriminate on the basis of gender, age, race, ethnic origin, disabilities, or religious affiliation. However, applicants are advised that McCurdy CAMP STARS is not able to provide special education programs.**

**IN CONSIDERATION of the covenants, conditions, and provisions herein contained, it is agreed by the parties as follows:**

**McCurdy CAMP STARS agrees to:**

1. Provide a safe environment to promote learning.
2. Demonstrate Christian values to Students, colleagues, and stakeholders.
3. Attempt to notify Parent(s)/Guardian(s) immediately of emergency conditions.

**Parent(s)/Guardian(s) agrees to:**

1. Pay the required fees in full, per one of the specified payment plans.
2. Complete and submit prior to start of the camp, the Emergency Information Card and Provide a physician's authorization form if the named child is required to carry an inhaler.
3. Allow McCurdy CAMP STARS to suspend or dismiss the named Child for disobedience of the rules and regulations of the camp, with the understanding that if noncompliance to said rules continues after parent notification has taken place, that student will be permanently dismissed from the program with no refund for any remaining time.
4. Allow McCurdy CAMP STARS to take the named Student to the hospital for emergency conditions, and to allow the attending physician to perform such medical procedures the physician deems necessary.
5. Release and hold harmless McCurdy CAMP STARS, its agents and employees from all claims, damages or other liabilities for injuries to the named Student, unless injury results from gross negligence on the part of the school.
6. Hold McCurdy CAMP STARS harmless in case of loss, theft or destruction of the named Student's property which has been brought to campus.
7. Allow McCurdy CAMP STARS to search the named Child and his or her property, including but not limited to a backpack, and/or storage space.
8. Read, sign and abide by the terms of this contract and the camp regulations and policies as explained in the CAMP STARS Guidelines.
9. Allow McCurdy CAMP STARS to use the named child's picture for promotional purposes.
10. Complete all forms necessary for enrollment, including health/immunization records and medical forms.
11. Bring the child to CAMP STARS regularly and encourage the student to participate and cooperate in order to benefit from the summer experience.

## TUITION AND FEES

### The Parent(s)/Guardian(s) agree(s) to pay the following:

Full Paid:	\$330.00
Free Lunch Program eligibility which has been confirmed by parent bringing in a letter from 2018-2019 participation.	\$200.00 discount <b>per child</b> <b>(Fee reduced to \$130.00)</b>
Reduced Lunch Program eligibility which has been confirmed by parent bringing in a letter from 2018-2019 participation.	\$150.00 discount <b>per child</b> <b>(Fee reduced to \$180.00)</b>
Or a Multi-sibling discount: Up to 3 siblings will be allowed for a sibling discount.	First child - \$330.00 Second and third child - \$300.00

### Tuition: The total tuition for summer 2019(6 weeks) is \$330.00 per child. Fees:

1. A tuition fee of \$330 per Student, with a maximum of \$300.00(\$30.00 discount), **for up to 3 siblings**, (non-refundable). If there are more than 4 siblings, the rest of the payment fee that a family will pay per child will be \$330.00.
2. A Safe Sanctuary fee of \$30.00 for all parents wishing to volunteer in the classroom or on out of class excursions such as field trips or field events.
3. The cost of any materials or property damaged or destroyed by the Student.
4. Lunches, milk, and one snack will be provided and included in the tuition fee paid for the camp.

### The Parent(s)/Guardian(s) agree(s) to one of the following payment options:

1. One payment in full of the tuition and fees at the time of enrollment and no later than May 30, 2019.

### The Parent(s)/Guardian(s) agrees to the following payment regulations:

1. Bad checks are subject to a returned check fee of \$25.00 and child's slot will be forfeited and given to someone else.
2. If parents are divorced/separated, does the non-custodial parent have access to the academic/financial account?
